# THE OCCUPATIONAL SAFETY AND HEALTH (GENERAL ADMINISTRATIVE) (AMENDMENT), RULES, 2018

Citation and commencement G.N No. 149 of 2015

- 1.-(1) These Rules may be cited as the Occupational Safety and Health (General Administrative) (Amendment) Rules, 2018 and shall be read as one with the Occupational Safety and Health (General Administrative) Rules, 2015 hereinafter referred to as the principal Rules.
- (2) These Rules shall be deemed to have come into operation on 01<sup>st</sup> July, 2018.

Amendment of the Rules

- 2. The principal Rules are amended -
- (a) in Rule 3-
  - (i) in subrule (1) by deleting the words "upon payment of application fees as set up in the First Schedule" appearing in paragraph (b);
  - (ii) by deleting subrule (2);
  - (iii) by renumbering subrule (3) as subrule (2);
- (b) in the First Schedule by-
  - (i) deleting the enabling provision and substituting for it the following:

"(Made under rule 7(2))"

- (ii) deleting the title "WORKPLACES REGISTRATION FEES" together with items 1 to 20 appearing in the Table to that Schedule;
- (iii) deleting the title "OCCUPATIONAL SAFETY
